The aforementioned serial detailed during December of 2001, a group of African-American Muslims moved two or three trailer homes on to a rural property located on Brazoria County Road 3 outside of Sweeny, Texas. 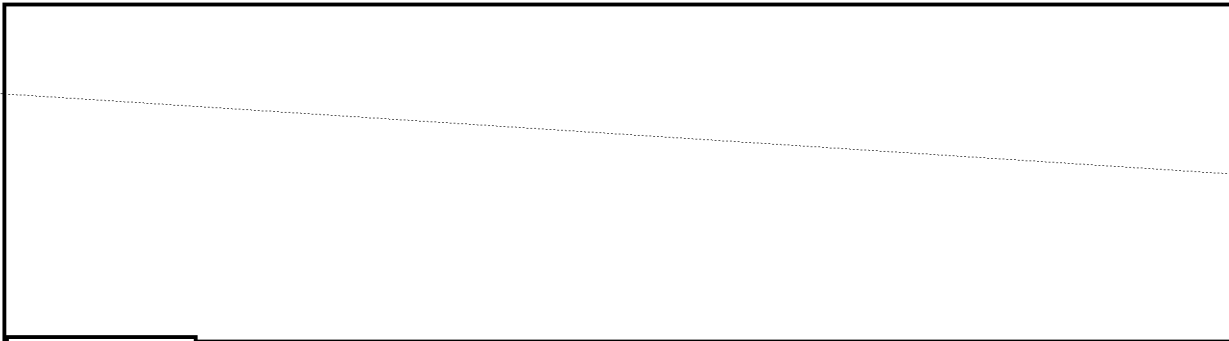

property consist of a seven to ten acre tract in an extremely wooded area. The area is so rural it is quite common for residents to shoot firearms for target practice or hunting on private property without interference from law enforcement. The property is owned by [redacted] and his wife [redacted]. Both reside on the property. At the time of the shooting incident, the trailers appeared to be new. [redacted] is believed to be employed by [redacted] as a [redacted] is unemployed. At the time of the shooting incident, [redacted] was not present. However, he arrived late at the scene and acted as the spokesman for the group as members began to congregate. The trailer homes provided residence for several families who apparently live in a communal arrangement. The trailer homes were of single width size. During the crime scene investigation, approximately 12 African American males were present. Approximately five were residents of the commune. The others were believed to be residents of the town of Sweeny, Texas. Investigators advised there appeared to be approximately seven women and children, to include a 10 month old infant, living within the commune. [redacted] would not allow direct interviews of the women.

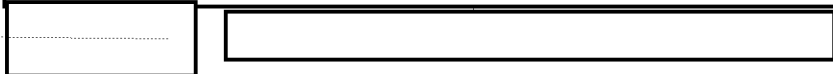

Detectives were not allowed to enter the trailer homes for interviews of potential female witnesses. The women covered their faces in the presence of other males. Witness statements made by the women were obtained by passing interview forms from the Detectives through [redacted] (or other males) to the women and by having the written statements returned to the detectives by the men. Subsequently, Houston has identified several of the MOA membership who were present at the trailer homes.

**Basis for Investigation:**

(U) The captioned investigation of the Muslims of the Americas is based upon specific and articulate facts giving justification to believe they are engaged in international terrorism or activities in preparation thereof pursuant to FCIG, Section III.C.1.b.6.

(U) The Muslims of the Americas (MOA) is a North American international radical fundamentalist group. It emerged in 1982 as a splinter group of Dar-UL Islam which previously espoused calls for young men to join Afghan guerrillas in their fight against the Soviet Union. The MOA is now an autonomous organization which possesses an infrastructure capable of planning and mounting terrorist campaigns overseas and within the U.S.

(U) ~~(S)~~ Based upon cumulative investigation by the Federal Bureau of Investigation, which has occurred in numerous field office divisions, MOA members have participated in ten murders; one disappearance; three fire bombings and one attempted fire bombing and; two explosive bombings with one attempted bombing. The documented propensity for violence by this organization supports the belief the leadership of the MOA extols its membership to pursue a policy of jihad or holy war against individuals or groups it considers enemies of Islam, which includes the U.S. Government. Members of the MOA are encouraged to travel to Pakistan to receive religious and military/terrorist indoctrination from Sheikh Gilani who leads an organization in Pakistan known as the Quranic Open University.

(U) ~~(S)~~ Individual MOA members reside throughout the U.S. The larger organized MOA communities are referred to as Islamic villages. The Federal Bureau of Investigation has identified one such Islamic village in a rural community outside of the town of Sweeny, Texas. It has been determined that on February 7, 2002, this particular Islamic village was the scene of an accidental shooting death of a MOA member by another MOA member when the member returned gunfire to unknown individuals who were harassing the MOA commune at Sweeny, Texas. To date, at least eight individuals have been identified as being members of the Sweeny, Texas enclave.

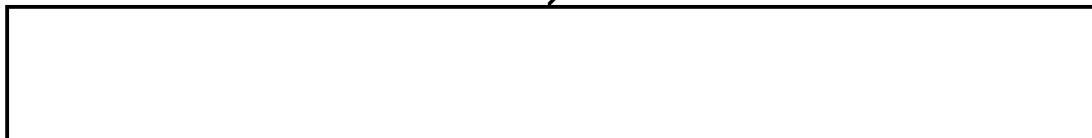
