INDICTMENT

The Grand Jury Charges:

Count One

Interstate Threatening Communications  
(Violation of 18 U.S.C. § 875(c))

On or about December 4, 2021, in the Amarillo Division of the Northern District of Texas, and elsewhere, **Christopher Stephen Brown**, also known as Madrikh Obadiah, defendant, knowingly and willfully did transmit in interstate commerce a threat to injure the person of another; to wit, the defendant made a telephone call to Chabad Lubavitch Headquarters and threatened to injure L.S., Y.K., and M.K. by tearing their eyes and tongue out.


In violation of Title 18, United States Code, Section 875(c).

Count Two  
Interstate Threatening Communications  
(Violation of 18 U.S.C. § 875(c))


On or about December 5, 2021, in the Amarillo Division of the Northern District of Texas, and elsewhere, **Christopher Stephen Brown**, also known as Madrikh Obadiah, defendant, knowingly and willfully did transmit in interstate commerce a threat to injure the person of another; to wit, the defendant made a telephone call to Chabad Lubavitch Headquarters and threatened to kill L.S., Y.K., and M.K.

In violation of Title 18, United States Code, Section 875(c).
