COUNT 1: WEAPONS - DANGEROUS WEAPON - CARRYING WITH UNLAWFUL INTENT

did, with intent to use the same unlawfully against the person of another, go armed with a firearm, to-wit a rifle contrary to MCL 750 226 [750 226]
FELONY 5 Years or \$2,500.00

COUNT 2: WEAPONS - FIREARMS - POSSESSION OF A LOADED FIREARM IN OR UPON A VEHICLE

did possess in or upon a motor vehicle a certain firearm which was not a pistol or revolver, to-wit, a rifle, while said firearm was loaded, contrary to MCL 750.227c. [750 227C]
MISDEMEANOR 2 Years and/or \$2,500.00

COUNT 3: WEAPONS - FELONY FIREARM

did carry or have in his/her possession a firearm, to-wit a rifle, at the time he/she committed or attempted to commit a felony, to-wit carrying a dangerous weapon with unlawful intent, contrary to MCL 750 227b [750 227B A]
FELONY 2 Years consecutively with and preceding any term of imprisonment imposed for the felony or attempted felony conviction

COMMISSION OF A FELONY WITH A MOTOR VEHICLE ADVISORY

You are charged with the commission of a felony in which a motor vehicle was used. If you are convicted and the judge finds that the conviction is for a felony in which a motor vehicle was used, as defined in section 319 of the Michigan Vehicle Code 1949 PA 300, MCL 257.319, your driver's license shall be suspended by the Secretary of State [257 7326]

Upon conviction of a felony or an attempted felony court shall order law enforcement to collect DNA identification profiling samples.

The complaining witness asks that defendant be apprehended and dealt with according to law
